- (a) self-contained additives with maximum concentration in full animal feed, excluding antibiotics, coccidiostats and other pharmaceutical substances, growth-promoting substances, vitamins, provitamins and other substances of corresponding action with clear scientific specification, trace elements, enzymes, micro-organisms, carotenoids and xanthophylls, as well as anti-oxidants [Regulation 20 (1)].
- (b) Premixtures containing any of the following additives: vitamins, provitamins and substances of corresponding action with clear scientific specification, except vitamins A and D, trace elements except copper and selenium, carotenoids and xanthophylls, enzymes, micro-organisms, and antioxidants with specific maximum concentration in full animal feeds [Regulation 20(2)].
- (c) Compound animal feed to be placed on the market and which contain the following [Regulation 20 (3)]:
  - (i) self-contained additives classified as vitamins, provitamins and substances of corresponding action with clear scientific specification, except vitamins A and D, trace elements except copper and selenium, carotenoids and xanthophylls, enzymes, micro-organisms, and antioxidants with maximum concentration in full animal feed.

- (ii) Premixtures of vitamin, provitamin and substances of corresponding action with clear scientific specification, trace elements, carotinoids and xanthophylls, enzymes, micro-organisms and antioxidants,
- (d) compound animal feed containing self-contained additives or premixtures referred to in paragraph (c) above, for exclusive use in my farm unit [Regulation 20 (3)],

To this effect I attach herewith \*\* the following, based on paragraph (1) of Regulation 22 and Part A of Appendix 9:

- (a) the specified fee;
- (b) certified copy of the incorporation certificate and of the certificate by the directors of the company/certified copy of the certificate of registration of the trade mark;\*
- (c) certified copy of the registration certificate of my establishment, issued in accordance with the provisions of the Factories Law;
- (d) full details of the location, design, construction, operation and maintenance of the buildings and technical equipment of the premises and the storage conditions for the materials;
- (e) details of the number, qualifications and technical knowledge of the personnel;
- (f) the name and qualifications of the person responsible for the production of the materials;
- (g) details of the quality control programme of the materials at the critical stages of the production process;
- (h) name, address and telephone number of the independent chemical laboratory where the chemical analyses will be carried out (when the establishment does not have own laboratory).
