APPLICATION FOR REGISTRATION

I (β). In the case where an application for registration is not approved by the Council, 50% of the fee is returned to the applicant, and the other 50% is kept by the Council for the assessment of the application form and other documents.

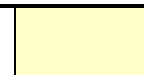
